- Approve Consolidated Pre-Construction Forms – Resolution 07-2018. Pre-construction and flood permit forms combined. Motion by E. Bogert, seconded by J. Beishline. Motion carried.
- Approve Ordinance 04-2018 - Updated Floodplain Ordinance. Changes only clarify some definitions. Motion by J. Beishline, seconded by E. Bogert. motion carried.
- WC/Liability Insurance Package – EMC/Kilmer - \$15,307 - (\$1277 less than 2018 - \$2,576.30 Dividend for 2017). E. Bogert made motion to accept Kilmer proposal, seconded by J. Beishline. Motion carried.
- Set 2019 Meeting Dates – January meeting 1/7/19 @ 6PM. 2019 dates will be advertised. Motion to set dates by E. Bogert, seconded by J. Beishline. Motion carried.
- Quotes for Used Roller – Bradco Used 2000 hours - \$17,500 – Used 1400 hours - \$19,500; Cleveland Brothers Used 223 hours \$31,360; Hile Enterprises Used 1789 hours includes trailer \$15,000. Township has been renting Hile roller for some time. Motion to purchase from Hile by J. Beishline, seconded by E. Bogert. J. Kline abstained.

- Generator stopped working. Was not cost effective to have repaired. Hunter Electric installed new generator. Act 147 money from Emergency Management will help defray cost.
